 Annual Statistics of Scientific Procedures on Living Animals Great Britain 2016, have been published by the Home Office, showing the number and types of procedures conducted in England, Scotland and Wales.

Understanding Animal Research (UAR) has <u>published an article about the statistics</u>, explaining rises and falls of species, suffering, and purpose of research. If you would like any more information on the statistics, they encourage anyone to get in touch.

Commenting on the publication of the 2016 data, Dr Virginia Acha, ABPI's Executive Director of Research, Medical and Innovation, said: "The Government publishing annual animal research statistic data every year is a valuable part of efforts by universities, regulators and the pharmaceutical industry to be transparent and provide more information to the public about research using animals, which research shows the public wants. As signatories of the Concordat on Openness on Animal Research in the UK, ABPI and its members welcome this continued openness about the use of animals and are proud of the work we and our members are doing in reducing, where possible, the use of animals in research and finding effective, alternative methods to ensure the safety and efficacy of new medicines before given to patients".
