4. Other things to look out for over the next few months

Finally I have to bring to the attention of the membership an issue that the Executive Committee have been informed about relating to research misconduct by a previous member of this Society.

The University of Liverpool undertook a detailed investigation that commenced in 2017 regarding alleged research misconduct by Dan Antoine. The University of Liverpool found that malpractice had directly influenced and undermined the findings of the research undertaken and published by Dan Antoine. The result of the investigation concluded that research misconduct by Dan Antoine had taken place and that the allegations against him upheld. The outcome of the investigation is provided in an article published by the University in August of this year https://news.liverpool.ac.uk/2020/08/17/further-update-on-research-misconduct-investigation/.

Given this information the BTS Executive Committee, at its meeting on the 22nd September 2020, they decided to nullify the Early Career Award presented by the Society to Dan Antoine in 2013 and to remove links to the report he presented in 2016 about his experiences as the BTS-ASCEPT Lecturer. This has been done.

The Executive Committee have now put in place a Code of Conduct which all new members will sign up to. Our current membership should be aware of this Code and can find it here: https://www.thebts.org/information/policies/
