Vacancies- Food Standard Agency Committees

The Food Standards Agency (FSA) are inviting applications from science experts to join their independent Scientific Advisory Committees (SACs). The work of the Scientific Advisory Committees is highly valued by the Government as it is fundamental to ensure excellent safety standards and effective, proportionate regulation of food and feed in the UK. The FSA are looking for 18 new experts to further strengthen the expertise in our Scientific Advisory Committees, ensuring that the UK's regulation for food and feed safety continues to be informed by the best independent and most recent scientific advice. The overall time commitment will depend on the extent of members' participation in the groups' meetings and FSA's strategic needs, but a minimum commitment is expected to be around 10 days a year, including attendance at six meetings. The FSA are committed to promoting and encouraging equality, diversity, and inclusion amongst their scientific committees and welcome applications from all sections of the community. The FSA are particularly eager to address underrepresentation on advisory committees of women, people from ethnic minorities and people with disabilities. All appointments are based on merit and the principles of independent assessment, openness, and transparency of process.
