This meeting is supported by donations or purchase of exhibition space by the companies listed in the congress App and is limited to meeting the cost of the meeting, with no input into the scientific programme. The overall program has been designed based on the principles of Equality, Diversity and Inclusion. However, depending on the symposia which delegates select to attend, some apparent imbalance from an EDI perspective may be observed.
